HOW TO COMPLETE THE APPLICATION PROCESS

- 1. All first time borrowers at Edison State College are required to complete an Entrance Counseling Interview before their loan will be disbursed.** You may access the counseling session on the internet. Go to www.edison.edu (do not login to the My Edison) and click on **Student Services** from the list on the left side of the screen. Then select **“Financial Aid”** on the next screen. From the list on the right side of the Financial Aid page select **“Student Loans”**. This will open a page explaining Stafford Loans. Below the circle of lenders is a link to the Loan Counseling. Follow the instructions to complete the required Entrance Counseling.

- 3. Keep a copy for your records.**
- 4. FIRST TIME BORROWERS AT EDISON:** Upon receipt of this completed form, the Financial Aid Office will review your eligibility. If your request is approved, the loan information will be transmitted to your lender for processing. Depending upon when you submit your Student Loan Request Form, it may take from 2 to 8 weeks to process your loan. ***First time borrowers need to sign the Master Promissory Note online.*** Go to **“Student Services”**, click on **“Financial Aid”** and then select the link that says **“Student Loans”**. Scroll down on the page to the circle of Lenders. Scroll your mouse over **YOUR** lender and it will show up on the middle of the circle. Click on **“e-Sign Your MPN”** underneath **your lender** and follow the prompts to complete the MPN online. Call the Financial Aid Office with questions. NELNET will notify you that the loan has been guaranteed and direct you to sign the Master Promissory Note (MPN), accessed online at the Edison State College website.
- 5. Your funds will be received by the college by electronic funds transfer and credited to your Edison student account. Any refund due will be issued to you as a refund through the Edison One card option you choose. You must continue to meet all eligibility requirements at the same time funds are received by the College for disbursement to your student account. Student loan status can be monitored at www.edison.edu on My Edison.**
